

Center for Coaching Certification Participant Enrollment Agreement

The application for each program offered by the Center for Coaching Certification, CCC, states the program name and price plus states that it includes all class materials, classes, group sessions, and coaching sessions required for each certification. Applications for each program are on the website and completed by participants to enroll. Additionally, the following information is on each application completed as part of the registration process:

Applicant hereby accepts and agrees that completing the program and earning the associated certification from CCC requires the following:

 \Box Attendance and participation in all segments of the program. With advance approval, one of the training webinars may be made-up. This involves listening to the recording and then scheduling time with the trainer to make-up the required live contact hours.

□ Complete the assignments from each webinar and during the practicum: in your own words answer the questions given and meet the length requirement.

Class materials are most easily provided through Basecamp. Being in a Basecamp group means others in your group can see your name and email address. Do we have your permission to add you to your class group in Basecamp? Yes / No

Prior to earning certification, applicant understands and agrees to complete the course work, attend all hours of training and fully participate, complete research, practice, and report assignments, fully participate in the coaching practicum, submit all evaluations, and complete the case study assigned. Certification is possible within offered schedules; applicant has up to twelve months to complete the course. A certificate is issued upon completion showing the program approvals and accreditations for hours. Applicant agrees and understands that any opportunity for make-up work is at the discretion of the trainer. Transferring to a different class before starting is based on space available. If you attend part of the program with one class and part with another class, there will be an additional fee of \$250.

The ICF has approved the separately offered Certified Professional Coach and Certified Master Coach programs as ACSTH - Approved Coach Specific Training Hours

- The Certified Professional Coach program is ICF-approved for 30 hours, accredited by IACET to offer 3 CEUs, and 3 AICI CEUs may be earned. Please note that while this course is accredited by the Association of Image Consultants International (AICI) certification earned through the trainer upon completion of this course is entirely independent from AICI's certification programs. - The Certified Master Coach program is approved by ICF for 35 hours and accredited by IACET to offer 3.5 CEUs.
- The Certified Coach Specialist program is approved by ICF for 35 hours and accredited by IACET to offer 3.5 CEUs.
- The Coaching Experience Class is approved by ICF for 30 Hours and accredited by IACET to offer 3 CEUs.
- The Mentor Coaching meets the ICF requirements.

Completing a form means agreeing to your information being held in our records.

Cancellation Policy: In the event you must cancel participation, up to seven days prior to the start of the first program webinar you may request a refund of the amount less a twenty percent processing fee; six days or less prior to the start of the first program webinar you may request a refund of fifty percent of the registration. You may transfer your full registration to someone else up to three days prior to the start of the first webinar. Transferring to a different class before starting is based on space available.

Transfer Policy: If you attend part of the program with one class and part with another class, there will be an additional fee of \$350.

The Center for Coaching Certification is focused on the integrity of all coach training programs. To ensure the student experience is honored and certification standards held true, payment or the registration fee must be paid to hold a space in the program and the full amount is due in before the start of the program.
